


The undersigned is directed to refer to the above subject and to say that consequent upon issuance of 'No Objection Certificate' by Directorate of Curriculum and Teacher Education Khyber Pakhtunkhwa, Abbottabad vide No. 6851-54/L-02/C&TR/DCTE/NOCs/G-V/Moonlight, dated 1st October, 2021 and subsequent notification No. F.1-3(IC)/2021 dated 5th May 2021 issued by the Ministry of Federal Education and Professional Training, review certificates have been issued. Accordingly, the rapid assessment committee notified vide this office notification No. 1(2)2021/NCC/TB/English/Moonlight dated 27th October 2021 critically assessed the review process. National Curriculum Council Secretariat, being the competent authority is pleased to approve printing and publication of the updated manuscript of the English textbook for Grade 5 based on the Single National Curriculum, developed by Moonlight Publishers, Lahore with the following terms and conditions:

- i. The recommendations of the Rapid Assessment Committee, being final, are to be incorporated.
 - ii. The certificate issued by the review committee will be printed on the first page of every textbook.
 - iii. The textbooks cover all the SLOs in accordance with the Single National Curriculum for Class-Pre I-V.
 - iv. The approval is valid till the new curriculum is approved. However, Moonlight Publishers, Lahore will improve/update/revise any part or the whole textbook based on the feedback from the field during implementation and submit improved version for approval.
 - v. The textbooks are free from all biases related to cultural, ethnic, and/or linguistic differences of the people of Pakistan.
 - vi. There is nothing repugnant to Islam, Pakistan and organs of the state in the textbook.
 - vii. All the maps used in the textbooks are approved by Survey of Pakistan.
 - viii. Name of Hazrat Muhammad رسول الله خاتم النبيين صلى الله عليه وعلى آله واصحابه وسلم has been written in the textbooks as per the notification No. F.1(1)/AD(Isl)/2016 dated 21st August 2020 issued by Ministry of Religious Affairs & Interfaith Harmony Government of Pakistan.
 - ix. Moonlight Publishers, before large-scale printing of the textbooks and supply to schools, will ensure that the textbooks are free from all grammatical/punctuation errors.
 - x. There is no violation of copyrights laws in use of content including illustrations and tables etc. in the development of these textbooks.
 - xi. Competent Authority has the right of revision at any time in the light of the feedback received from Teachers, Subject experts, community and other stakeholders.
2. Moonlight Publishers, Lahore is required to submit 12 (twelve) copies of the each printed textbook to National Curriculum Council (NCC) Secretariat for post-publication review.
